Independent Evaluation Process & Parent Portal Access

About the Evaluation (Independent & Third-Party)

- Sports Evaluations provides an option for **fully independent, third-party** evaluation process led by professional evaluators who **specialize exclusively in team selection** for your sport.
- To ensure fair and appropriate rankings against peers:
 - **Players:** a minimum of **64 data points** are collected per athlete.
 - **Goaltenders:** a minimum of **96 data points** are collected per athlete.
- Evaluators **do not receive names or personal athlete details** before, during, or after tryouts. Our software displays **only jersey number and color**—nothing more.

Your Confidential Parent Portal

- Each parent/guardian receives a **private portal** for schedules and updates.
- Access via www.sportsevaluations.com → **Login**, or go directly to: <https://app.sportsevaluations.com/player-schedule>.
- An **access code** will be emailed a few days prior to start of the tryout process to the **same address used for player registration**.
 - Didn't get it? **Check Junk/Spam** first.
 - Still missing? **Contact your category director** to confirm the registered email.

What You'll See in the Portal

- **Your athlete's schedule** and **directions/maps** to each facility.
- If your organization opts to release them, **rankings and/or data** will appear **in the portal**.
- Scores are posted **within 30 minutes** after the **scheduled session end time**.

Optional: Player Insights (If Offered by Your Organization)

- Some organizations enable an **optional, paid add-on** called **Player Insights** for deeper data access and player feedback.
- Availability is set by **your organization** and accessed via the **parent portal** when enabled.

Scheduling Notes (Please Read Carefully)

- The evaluation process is **fluid by design** to place athletes in the **correct competitive order** for team selection purposes.
- We **highly** recommend you review the full organization schedule with all dates/times so you are available for the schedule times for tryouts.
- **Exact dates/times for subsequent skates are confirmed 1–2 days in advance** and may change as the process unfolds.
- Movement **up or down** between groups can occur throughout—this is a **normal and essential** part of fair team selection.

Communication & Conduct During Tryouts

- **Do not reply** to Sports Evaluations emails or contact our staff directly **during the tryout window**; we will **not** respond so we can preserve independence and focus on data quality.
- **All questions must go to your organization’s category director or board.**
- At Complete Solution events, **please do not approach or speak with evaluators/assessors.** Our team will **not engage** with parents/guardians on-site to maintain strict impartiality.
